I. Program Overview

The Pharmacy Technology (PHM) curriculum prepares individuals for a career in pharmacy and it provides the opportunity to be a part of one of the fastest growing fields in health care. Pharmacy technicians work closely with pharmacists to help ensure that patients have the medications they need.

Employment opportunities include working with pharmacists in hospitals, drug and grocery stores, and other medical settings to help prepare and distribute medicines to patients. In many pharmacies, technicians screen and prepare orders, perform calculations, and assist in the management of investigational drug studies.

The Pharmacy Technology program is a competitive admissions program. Each year a maximum of 24 students are selected along with two alternates. Students are ranked according to the total score on the Pharmacy Technology Application Form. If you are not accepted and you wish to reapply, you must complete a new Pharmacy Technology Admission Form for the preferred application period.

II. Steps to Complete Before Applying for the PHM Program

CPCC College Admission

- Attend a Pharmacy Technology/ PHM Program Information Session at CPCC.
 The PHM program hosts information sessions for students interested in a detailed description of the program and the admission process. Dates and locations of these sessions will be posted on the CPCC Pharmacy Technology program website. Admission points can be earned by attending an Information Session.
- 2. Graduate from High School or completed the GED.
- Complete the CPCC College Admission Application.
 Applications are available online at www.cpcc.edu/getstarted or at any of the CPCC campus locations. Designate the Pharmacy Technology Holding Code (A55280P) as the program of interest on the College Admission Application.
- 4. Request an external official copy or copies of high school/GED and college transcripts be sent to CPCC Student Records, PO Box 35009, Charlotte, NC 28235-5009. Transcripts are processed in the order of which they are received. Please allow up to four weeks for processing. You will be notified via your CPCC student email when the evaluation is completed.
- 5. If your high school or college transcripts are not from the United States, you will need an International Transcript Evaluation reviewed by an agent outside of Central Piedmont Community College. A list of International Evaluators is available in the Counseling Department in the Central High Building on the CPCC Central Campus or through the National Association of Credential Evaluating Services (NACES) website. There is a fee for this service.

Required Testing

Take <u>required Math and English Placement testing</u> at a CPCC Testing Center. Students with college credit for English and Algebra may be exempt from the English and Math Placement tests as determined by the CPCC Transcript Evaluator. All students must meet with an academic advisor to review placement test scores.

Required Coursework

If required based on placement tests or high school GPA score, complete all required Developmental Studies Courses (DRE 098 & DMA 050) with a grade of "C" or better.

Get a Head Start!

Any non-PHM prefix course required for the Pharmacy Technology program can be taken prior to submitting the PHM Program Application. See the Education Plan on the Pharmacy Technology website for the list of required courses. Completion of designated courses will also increase your application score.

III. Pharmacy Technology Program Admission Requirements

The Diploma Program prepares graduates to perform essential functions in various areas of retail pharmacy practice.

The AAS Program prepares graduates to prepare prescription medications, mix intravenous solutions, and other specialized medications, update patient profiles, maintain inventories, package medication in unit-dose or med-card form, and gather data used by pharmacists to monitor drug therapy. Graduates may be employed in retail, hospitals, nursing homes, research laboratories, wholesale drug companies, and pharmaceutical manufacturing facilities. The AAS curriculum is taught from an advanced perspective pertaining to specific advanced levels of employment. At this time, AAS degrees are only recognized in specific hospital settings.

Graduates of either program are eligible to take the National Certification Exam administered by the Pharmacy Technician Certification Board (PTCB) to become a Certified Pharmacy Technician.

Points are earned from the following areas:

- 1. Attendance at a Pharmacy Technology Session
- 2. Graduate or Certified as a Pharmacy Technician (CPhT)
- 3. Transcripts for Completed Academic Courses

The points will be recorded on the application form on page 4. Application must be fully completed (typed, not hand-written) and submitted along with the other supporting documents.

IV. Acceptance Into the Program

Upon acceptance into the Pharmacy Technology program, students are required to:

- Submit results of a North Carolina and/or national criminal background check at their own expense.
- Students must also complete a medical exam, provide record of immunizations, show proof of medical insurance and carry CPCC's accident insurance.

The required forms are available at the <u>PHM Program Website</u> and will be discussed at the mandatory Pharmacy Technology Orientation session for students who are accepted into the program.

 After acceptance and enrollment in the program, students are required to take all courses as scheduled and sequenced. This is considered a lockstep sequence program.
