Request IRS Documents

To get an IRS Tax Transcript, and/or Wage and Income Transcript, you can submit a request:

- Online: Go to the IRS website, select “Get Your Tax Record.” Select “Get Transcript Online” or “Get Transcript by Mail.” Make sure to request the “Return Transcript,” **not** the “Account Transcript” if you are requesting the federal tax forms.
- By Phone: Call 1.800.908.9946 (IRS Tax Return Transcript only)
- Through a Paper Request Form: IRS Form 4506-T. Check box 6a for return transcript and/or box 8 for a Wage and Income transcript. Or, IRS Form 4506T-EZ (IRS Tax Return Transcript only). The transcript is generally received within 10 business days from the IRS’s receipt of the paper request form.

2023 Income Tax Return Information for Individuals with Unusual Circumstances

Individuals Who Do Not Have a Social Security Number (SSN), Individual Tax Id Number (ITIN), or Employer Identification Number (EIN) and Did Not File and Were Not Required to File 2023 IRS Income Tax Return

If an individual does not have a Social Security Number, ITIN, or EIN and is unable to obtain a "Verification of Non-Filing Letter" from the IRS, provide the following documents:"

- a) A signed and dated statement certifying that individual does not have a Social Security Number, ITIN, or EIN; and a list of the sources and amounts of earnings, and other income for 2023 year.
- b) And, if applicable, a copy of W-2s or an equivalent document(s) for each source of employment income received in 2023.

Individuals Who Filed an Amended IRS Income Tax Return

An individual who filed an amended IRS Income Tax Return for tax year 2023 must provide:

- a) A 2023 IRS Tax Return Transcript (that will only include information from the original tax return and does not have to be signed), or any other IRS tax transcript(s) that includes all of the income and tax information to be verified; **and**
- b) A signed copy of the 2023 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," filed with the IRS or documentation from the IRS that include the change(s) made by the IRS.

Individuals Who Were Victims of IRS Identity Theft

A victim of IRS tax-related identity theft must provide:

- a) A Tax Return Database View (TRDBV) transcript obtained from the IRS, or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified, **and**
- b) A statement signed and dated by the tax filer indicating that they were a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.

Individuals Who Filed Non-IRS Income Tax Returns

- A tax filer who filed an income tax return with Guam, the Commonwealth of the Northern Mariana Islands, the Commonwealth of Puerto Rico, and the U.S. Virgin Islands may provide a signed copy of their income tax return that was filed with the relevant tax authority. However, if we question the accuracy of the information on the signed copy of the income tax return, the tax filer must provide us with a copy of the tax account information issued by the relevant tax authority before verification can be completed.
- A tax filer who filed an income tax return with the tax authority for American Samoa must provide a copy of their tax account information.

- A tax filer who filed an income tax return with tax authorities not mentioned above, i.e. a foreign tax authority, and who indicates that they are unable to obtain the tax account information free of charge, must provide documentation that the tax authority charges a fee to obtain that information, along with a signed copy of their income tax return that was filed with the relevant tax authority.

Individuals Granted a Filing Extension by the IRS

An individual who is required to file a 2023 IRS income tax return and has been granted a filing extension by the IRS beyond the automatic six-month extension for tax year 2023 must provide:

- a) A copy of IRS Form 4868, "Application for Automatic Extension of Time to File U.S. Individual Income Tax Return," that was filed with the IRS on or over October 1, 2023;
- b) A copy of the IRS's approval of an extension beyond the automatic six-month extension for tax year 2023;
- c) Verification of Non-Filing (VNF) Letter (confirmation that the tax return has not yet been filed) from the IRS or other relevant tax authority dated on or after October 1, 2024 or a signed statement certifying that the individual attempted to obtain the VNF from the IRS and was unable to obtain the required documentation.
- d) A copy of the IRS Form W-2 for each source of employment income received or an equivalent document for tax year 2023 and,
- e) If self-employed, a signed statement certifying the amount of the individual's adjusted gross income (AGI) and the U.S. income tax paid for tax year 2023.

An individual granted a filing extension beyond the automatic six-month extension may be required to submit tax information using the IRS Data Retrieval Tool, by obtaining a transcript from the IRS, or by submitting a copy of the income tax return and the applicable schedules that were filed with the IRS that lists 2023 tax account information.
